The grounds for personal data processing shall be Article 24 of the Constitution of the Russian Federation, Article 6 of Federal Law No. 152-FZ "On Personal Data" dated July 27, 2006; this Consent to Personal Data Processing for Website Users and any contracts concluded between the Operator and the personal data subject.

5. The personal data processing may involve the following actions: collection, systematization, storage, extraction, transfer, destruction, other actions, recording, accumulation, use, rectification, deletion.

6. The Operator hereby informs the User that the expected users of personal data are the Operator's employees (officials) and the persons engaged by the Operator under a civil law contract.

7. The User is aware that:

— This Consent to Personal Data Processing shall remain valid indefinitely, and I may revoke it by sending a notice to the Operator's email address at: info@index1520.com marked "Revocation of Consent to Personal Data Processing."

— I shall be entitled to access my personal data, demand that my personal data be rectified (updated, changed) as well as deleted and destroyed in case it is processed by the Operator in breach of the legitimate rights and interests and the laws of the Russian Federation.

— If the Consent to Personal Data Processing is revoked, the Operator shall be entitled to continue to process the personal data without my consent upon the grounds stipulated in Clauses 2.11 in Part 1 of Article 6, Part 2 of Article 10 and Part 2 of Article 11 of Federal Law No. 152-FZ "On Personal Data" dated July 27, 2006.

8. By giving this Consent, the User hereby confirms that they are the subject of the submitted personal data, and also confirms the reliability of the submitted data.

9. This Consent shall remain valid at all times until the personal data processing is terminated according to Clause 7 hereof.
